Instructions for Graduate Students

All forms must be completed properly and mailed via USPS, or hand delivered to the All Saints' Office by the deadline noted below.

1. All applications must be accompanied by the following:
 - a. Transcript of all college years from the previous institution(s) attended (DO NOT have the grades sent directly to the All Saints' Scholarship Board; the grades should be forwarded by the applicant with the application.)
 - b. A copy of the most recent IRS Form 1040, pages 1 and 2, indicating family income (See #3).
2. Part II of the application must be prepared by the parent or guardian, unless the applicant is self-supporting, in which case the applicant would complete Part II.

3. All applications and the required supporting materials should be sent to the following:

The application should arrive no later than 4:00 p.m., on Monday, February 10, 2020.
APPLICATIONS RECEIVED AFTER THAT DATE WILL NOT BE CONSIDERED.
Do Not send your application via Certified Mail or Return Receipt.

4. Scholarships will be awarded in early May, and all applicants will receive scholarship information at that time.
5. When applicants receive scholarship grants, the treasurer of the All Saints' Scholarship Board will be authorized to make payment of the grants for the next term only after receiving a copy of the institution's official registrar's tuition statement. Checks for the grants are made payable to the institution.
6. All scholarship grants are given for ONE YEAR ONLY. Applications and forms for Re-applications are available in early December each year on the All Saints' Episcopal Church website www.allsaintsvabeach.org
7. **Before submitting the application, applicants should check to make sure that all parts have been completed and that the transcript and IRS Form 1040, pages 1 and 2, are included.**
